NEW YORK ARTICLE 9-B Condominium Act

The Condominium Declaration must also include the address within the United States to which the New York Secretary of State shall mail copies of such process. The Declaration and any amendment thereof must be enclosed in a legal backer/cover sheet which contains the title of the document and the name and address of the filer.
