MINIMUM WAGE & OVERTIME WAGE RATE - The New Jersey State Wage and Hour Law establishes a minimum wage rate and overtime rate for all workers in New Jersey that are covered by the Act. In New Jersey, the statute of limitations on personal injury cases is two years from the time the injury occurred. Wait longer than two years without a valid exception, such as temporary incapacitation following the injury, and the court may not hear your case at all.
